

# About Presumptive Eligibility Services for Pregnant Women

## What is... Presumptive Eligibility?

Presumptive Eligibility is also known as **PE**. It is a Medi-Cal program that provides temporary prenatal, miscarriage and abortion care to low-income women and teens.

**Immigration status does not matter.**

**With PE, you can receive the following services immediately and for free!**

## Services covered by PE:

- ✓ Pregnancy tests
- ✓ Prenatal care visits
- ✓ Services for miscarriage or abortion
- ✓ Medications prescribed for pregnancy
- ✓ Some preventive dental care

PE does not cover hospital labor and delivery and other inpatient services, but Medi-Cal does.



## How do I enroll in PE?

1. Call a Medi-Cal clinic or doctor—you can call 211 for names of doctors or clinics, or go to <http://lapublichealth.org/mch/cpsp/cpspproviders/providerlist.htm>  
Ask the doctor or clinic if they offer PE.
2. Make an appointment and tell the clinic or doctor you do not have health insurance. Apply for PE there.  
(If you qualify, you can receive a temporary PE card and Medi-Cal services the same day.)

Fill out a Medi-Cal application. Your doctor or clinic may have a Medi-Cal application for you, or call **1-877-597-4777** (free) for a mail-in Medi-Cal application to be sent to you, or to find out where you can apply in person. To see other locations to apply:

3. Be sure to check the box on the application for medical care you got in the last three months, in case you have services that PE won't cover. (Apply for Medi-Cal even if you miscarry, to get the most coverage possible.)
4. Mail the Medi-Cal Application to:

If you have already turned in a Medi-Cal application and need prenatal care or other services, just follow steps 1 thru 3.

Take your PE card with you to your medical appointments until you receive a letter from Medi-Cal.

PE will pay for PE-covered services while you wait for a decision from Medi-Cal.

If you have applied for Medi-Cal and your PE card date is ending, your doctor or clinic can extend your PE until your Medi-Cal gets approved.

When your Medi-Cal is approved, it will pay for your hospital labor and delivery services and other medical services that PE does not cover.

**Reminder: PE covers miscarriages and abortions.** However, it is best to also apply for regular Medi-Cal before the PE end date or as soon as possible afterward to be sure every cost is covered. Ask for “retroactive” Medi-Cal.

### What if I am a Minor?

If you apply for PE as a minor, you **must** list your parent's income. However Medi-Cal has a special program called "Minor Consent" or "Sensitive Services" that does not count parents income. It provides some confidential services to people under 21 who live with their parents. Minor Consent covers family planning, pregnancy, abortion, sexual assault treatment, diagnosis and treatment of sexually transmitted infections, substance abuse and outpatient mental health services.

You must apply with a county worker in a Medi-Cal office or a clinic site.

Eligibility is month to month, so you need to see your worker each month to recertify.
