RE: AB 2385 (Ting) - Support

Dear Assemblymember Eggman and Assembly Agriculture Committee Members:

[Name of your organization] supports AB 2385, which would improve low-income Californians' access to nutritious food through new incentives for nutrition benefit program recipients to shop at farmers' markets.

AB 2385 would establish the Market Match Nutrition Incentive Program (MMNIP) in the Department of Food and Agriculture to award grants to Market Match programs. These programs increase the purchasing power of CalFresh, WIC, Senior Farmers Market, and SSI and SSDI recipients when they use their nutrition benefits to purchase fruits, nuts, and vegetables at farmers' markets by doubling the value of those benefits at the farmers' market. State investment in Market Match programs would directly benefit our state's small- and mid-sized farmers while making nutritious food more accessible for California's most economically disadvantaged people who are frequently unable to buy fresh food in their communities.

Under the new Food Insecurity Nutrition Incentive provision in the recently passed federal Farm Bill, the United States Department of Agriculture shall award matching grants totaling \$20 million per year for five years to support such nutrition incentive programs. The combination of California's unparalleled agricultural bounty, vast network of farmers' markets and entrenched poverty gives us a unique opportunity secure federal funds to expand the reach of nutrition programs in communities where they can most efficiently serve those most in need.

California has pioneered the Market Match approach in a four-year pilot. A report by Roots of Change indicated a six-fold return on investment in farmers' market sales. The program is serving 37,000 families based on only \$237,000 in available Market Match incentive dollars. A \$2 million program in California, matched with \$2 million from USDA, could boost healthy food access to \$18 million for over 100,000 families and generate hundreds of new farm jobs.

In California's Safety Net

- The Supplemental Security Income (SSI)/ State Supplemental Payment (SSP) program gives cash assistance to 1.3 million aged, blind and disabled Californians. California funds the SSP portion of the grant. For 2014, the state allotted \$156.40 to the cash grant for individuals, bringing the overall total to \$877.40.
- The federal government provides an annual cost of living adjustment (COLA) to the federal portion of the grant based on the federal consumer price index.
- The California state government suspended the COLA for the SSP in 2009.
- The California Budget Project reports since 1990, the purchasing power of the individual SSI/SSP grant declined by 32%.
- SSI/SSP grants for couples are lower in 2014 than they were in 2007.
- As of January 2014, the income of individuals solely receiving the SSI/SSP grant is 90.2% of the federal poverty level, placing over 1 million aged, blind and disabled Californians in poverty.
- Restoring the SSP grant cuts would lift more than 1 million Californians out of poverty.
- These benefits will immediately filter into the local economy.
- We urge the Legislature to RESTORE THE GRANT CUTS AND PROVIDE COST OF LIVING ADJUSTMENTS FOR THE SSP!
