### 2012 - 2013 Federal Income Guidelines

# Adult Dental Services for Department of Developmental Services (DDS) Regional Center Consumers Restored

Effective January 13, 2012, the Medi-Cal Dental Program (Denti-Cal) has begun to process claims for regional center consumers (also known as DDS beneficiaries or consumers of DDS) age 21 and over that have Medi-Cal and do not reside in a licensed health facility.

These regional center consumers are eligible for the adult dental services eliminated in 2009 and are exempt from the \$1,800 annual adult dental cap. For more information or for a copy of the Denti-Cal Bulletin click <u>HERE</u>.
