# **Special Enrollment in Covered California**

Covered California is now CLOSED for enrollment until October 15, 2014 - EXCEPT if you qualify for special enrollment. A special enrollment period (SEP) is a time outside of the open enrollment period during which an individual has experienced a life event that makes them "qualified" to enroll in a Covered California Health Plan or to make changes to their existing Covered California Health Plan. Losing your existing insurance coverage or no longer qualifying for Medi-Cal is considered a "qualifying" event. This event would trigger a special enrollment period which allows individuals to enroll into Covered California even if it is not during the yearly open enrollment period. Other qualifying events include the loss of a job, marriage, divorce, birth of a child, moving to new county or moving to California. Note that pregnancy is NOT a qualifying event - only the birth of the child. A change in a person's immigration status which makes them newly eligible for coverage in Covered California is also considered a qualifying event. In most cases individuals have 60 days from the qualifying life event to enroll in new coverage.

There is no open enrollment period for Medi-Cal; people can apply at any time throughout the year.

## **California's Coordinated Care Initiative Training**

Neighborhood Legal Services of Los Angeles County (NLSLA) is offering free trainings on upcoming changes to Medicare and Medi-Cal for low-income seniors and persons with disabilities under California's Coordinated Care Initiative (CCI). These trainings will provide an overview of the different parts of CCI: 1) Cal Mediconnect- An integrated managed care plan for persons with both Medicare and Medi-Cal; 2) Mandatory Medi-Cal managed care for persons with both Medicare and Medi-Cal; 3) Managed Long-Term Supports and Services (MLTSS)- Medi-Cal Long-Term Supports and Services programs like In-Home Supportive Servics (IHSS) and Medi-Cal Long-Term Care will become Medi-Cal managed care benefits.
