While my 2 cents is predominately anecdotal, recently pregnant patients did not know they qualified for prenatal coverage through Medi-Cal due to Medi-Cal eligibility paperwork misunderstandings. OR some patients did not want be billed for a hospital fees because they didn't have medical insurance coverage, so they would intentionally avoid any initial preventative exams/prenatal care prior to giving birth. Not sure if this provides some insight, but thought I'd share.
