## **Guest Speaker:**

David Holtzman, volunteer for League of Women Voters, Los Angeles "California State Ballot Measures"

Mr. Holtzman, a volunteer for the League of Women Voters, took us through the (only) 12 ballot measures California faced in this election. Here are just a few highlights of the results, rather than the purpose only of each ballot measure:

- **Prop 14 Approved**. Authorizes California to issue \$5.5 billion in state general obligation bonds to continue funding stem cell and other medical research.
- **Prop. 15 Lost**. This measure would have provided \$6.5 billion to \$11.5 billion in new funding for public schools, community colleges, and local government services by creating a "split roll" system that increased taxes on large commercial properties by assessing them at market value, without changing property taxes for small business owners or residential properties for homeowners or renters. It lost by a very small margin; about 650,000 votes with over 17 million Californians voting (current count).
- **Prop. 16 Lost**. This measure would have eliminated California's ban on affirmative action policies. If passed, it would have allowed schools and public agencies to take race, ethnicity and sex into account when making admission, hiring or contracting decisions.
- **Prop. 17 Approved**. This constitutional amendment would allow people on parole for felony convictions to vote after their state or federal prison term ends.
- **Prop. 18 Lost**. This constitutional amendment would have expanded voting rights for citizens who are 17, residents of the state and will be at least 18 years old at the time of the next general election, would have been allowed to vote in any primary or special election that occurs before the next general election.
- **Prop 19 Approved**. This constitutional amendment allows homeowners who are over 55, disabled or victims of natural disasters to transfer part of their property tax base with them when they sell their home and purchase a new one.
- **Prop. 20 Lost**. This ballot measure would have rolled back changes to California's sentencing laws, changing certain misdemeanor crimes to felony crimes. It would also make changes to the state's parole system and require people convicted of certain misdemeanors to submit DNA collection to a state database.
- **Prop. 21 Lost**. This measure is similar to one on the ballot in 2016 and would have allowed cities and counties to implement rent control for certain residential properties that are over 15 years old.
- **Prop. 22 Approved**. This proposition would exempt some gig workers mainly Uber and Lyft from being subject to Assembly Bill 5, a labor law that requires companies to label independent contractors as employees.
- **Prop. 23 Lost**. The measure would have required dialysis clinics to have a licensed physician, nurse or physician assistant on site during kidney dialysis treatment.
- **Prop. 24 Approved**. Allows Californians to block companies from sharing personal information and limit businesses' use of "sensitive personal information."
- **Prop. 25 Lost**. The proposition would have replaced California's cash bail system with a new pretrial release system based on public safety and flight risk.

Some wins and losses - and very difficult to predict. Thank you for being some of the record voter turnout this year nationally - keep up the good work!

#### Reminders:

**No Negative Action** - The ONLY ways that Medi-Cal should be cut off is if a beneficiary requests, or dies, or moves out of state! Please note that thousands are still inadvertently or through systems issues being cut off, but the state moves to put them back on Medi-Cal. Please contact DPSS or have your client contact DPSS's Customer Service Line if this happens.

"COVID Uninsured" -neither income nor immigration status matter, covers COVID testing, treatment, hospitalization. No public charge for any COVID-related service. See the state's page here, but also MCHA's information above.

"Waive", or Get Rid Of, Medi-Cal Premiums During the Pandemic Few Medi-Cal enrollees know that during the public health emergency, premiums paid monthly can we waived for MCAP, Optional Targeted Low-Income Children's Program and the Medi-Cal Access Infant Program (infants born to a person covered by MCAP for the pregnancy), County Children's Health Initiatives and the 250% Working Disabled Program. MCHA and other advocates have made suggestions about the posting, language and distribution of notices regarding the waived premium issue. ## Big Win for DACA!

On November 14, a <u>U.S. district court found</u> that Chad Wolf, who claimed to be the acting secretary of Homeland Security, did not have the legal authority to serve as the acting secretary of Homeland Security when he issued his July 2020 <u>memorandum whose provisions limit the availability of DACA</u>, and therefore that his memo was issued unlawfully. As a result of the Batalla Vidal v. Wolf decision, the Department of Homeland Security should return the DACA program to its initial form - reopening DACA to first-time applicants, restoring work authorization and renewals to two years, and making travel on advance parole available to DACA recipients without restrictions.

Women with asthma may be at higher risk for weight gain during pregnancy, NIH study suggests

Women with asthma are more likely than normal to gain weight during pregnancy and to retain weight 3 months after giving birth, suggests a National Institutes of Health study. On average, women with asthma gained 3.1 kg (just under 7 lbs) more after a full-term pregnancy than women without asthma. Among women with asthma, weight gain was greater with obesity. Weight gain was also greater with more severe asthma and with asthma triggered by exercise. The study authors suggest that their findings underscore the importance of pre-pregnancy counseling for women with asthma on the need to achieve and maintain a healthy body weight.

Medi-Cal Prescription Drug Coverage (Medi-Cal Rx) implementation delayed until April 1, 2021 from January 1.

Given the ongoing challenges and constantly evolving health care landscape associated with the unprecedented COVID-19 public health emergency (PHE), the Department of Health Care Services (DHCS), after careful consideration and in close partnership and collaboration with Magellan Medicaid Administration, Inc., has decided to lengthen the transition time to the full implementation of Medi-Cal Rx by three (3) months, until April 1, 2021. In the interim, all current prescription drug service processes and protocols, both effectuated by DHCS and Medi-Cal managed care plans (MCPs), will remain unchanged and in place until Medi-Cal Rx launches.

Registration deadline extended to November 21, 2020 for certain individuals who

Registration deadline extended to November 21, 2020 for certain individuals who received an Economic Impact Payment (EIP) for themselves but not for their eligible children.

Eligible people now include those with qualifying children who did not (and are not required to) file a tax return in 2018 or 2019 and who receive Social Security retirement, survivor or disability benefits, Supplemental Security Income (SSI), Railroad Retirement benefits, or Veterans Affairs Compensation and Pension (C&P) benefits. The IRS had previously only extended the deadline to November for adults who had not received their own Economic Impact Payment. Those who are eligible and have not yet received a stimulus payment for their dependent children can now use the Non-Filers tool on IRS.gov to enter their information. Eligible individuals who do not submit their dependent information before the November 21st deadline will have to wait until next year to receive the payment by filing a 2020 tax return.
