#### Section: Payment Responsibilities – Monthly Family Contributions

##### Healthy Kids for children ages 0-5

Your monthly premium is determined by family size and income. Your monthly premium will range from \$0 to \$6 for each child. The family maximum for all children in a family enrolled in the Healthy Kids 0-5 program is \$12 per month.

You have the option of paying six months of premiums in advance. If you choose this option you will get a 25% discount.

##### Healthy Kids for children ages 6-18

Your monthly premium is \$15 for each child. The family maximum for all children in a family enrolled in the Healthy Kids 6-18 program is \$45 per month.

**Section: General Information – Termination of Benefits**

**Healthy Kids for children ages 0-5**

L.A. Care will let you know if any of the benefits are terminated or ended. Coverage for your child will be terminated without your consent in the following conditions:

- Midnight on the last day of the month in which your child turns nineteen
- Midnight on the last day of the month in which your child's policy expires due to non-response:
  - unless L.A. Care receives payment on or before the 20<sup>th</sup> day after the due date, at which point the child will be reinstated with original effective date, or
  - unless L.A. Care receives payment on or later than the 21<sup>st</sup> day after the due date, at which point the child will be reinstated with a revised effective date and the family will receive written notice, or unless you contact L.A. Care Member Services to request and are granted access to the Healthy Kids premium assistance fund at which point the child will remain in the program
- Health plan terminates the program due to lack of funding

**Healthy Kids for children ages 6-18**

L.A. Care will let you know if any of the benefits are terminated or ended. Coverage for your child will be terminated without your consent in the following conditions:

- Midnight on the last day of the month in which your child turns nineteen
- Midnight on the last day of the month in which your child's premium is 60 days past due
- Health plan terminates the program due to lack of funding
